- (2) Agree to pay any such claim for loss, damages, costs, injury or death caused by, or
resulting from having such animal accompany me; and
- (3) Agree to indemnify the Facility and the Show Company and save them harmless against
any such claim or cause of action which may arise now or hereafter.
- (4) Agree to maintain for the duration of the Show comprehensive general liability insurance
of not less than \$5,000,000, such policy to contain a cross liability clause and name
T.I.C.C. Limited o/a The International Centre as an additional insured. Approval by the
Facility is subject to receipt and approval of insurance.
- (5) Agree that this Release is subject to my complying with by the rules and regulations set
forth in the attached Schedule "A", and may be rescinded by the Facility at any time
without notice if the Releasee is in breach of the rules and regulations.

The Releasee recognizes that The International Centre's policy prohibits the presence of animals
and I give this Release and Indemnification in consideration of The International Centre allowing
any such animal(s) to enter the site and the building(s) of The International Centre and the
exhibition space licensed by the Show Company.

Schedule "A"

Rules and Regulations regarding Animals

In the absence of the fully executed release contained herein, animals are specifically prohibited from entering the site of The International Centre or any of the buildings located thereon.

The following rules apply if the attached release is fully executed by all parties:

1. The animal must be in the building only during Show times and removed from the site of The International Centre daily.
2. The animal must be under full supervision of a trained adult keeper at all times while in the facility and kept in a cage or otherwise held by a leash when applicable, within the booth.
3. The animal must remain within the booth and must not wander down aisles or in public areas with or without an animal keeper.
4. The Releasee assumes full responsibility for all costs related to extra cleaning or damages resulting from the animal.
5. To facilitate animal waste disposal the trained adult keeper, where applicable, must take the animal to the stoop and scoop area designated by the Facility, and remove and dispose of the animal waste in a leak-proof sealed plastic bag. If stoop and scoop areas are not applicable, animal waste must be removed and disposed of in a leak-proof sealed plastic bag. Additional fees to Show Management may apply if additional cleaning is required.
6. The Releasee or Show Company is required to provide hand sanitizing stations at each location where animals are displayed.
7. Animals must be treated in accordance with the guidelines of the Ontario Society For The Prevention Of Cruelty To Animals.
